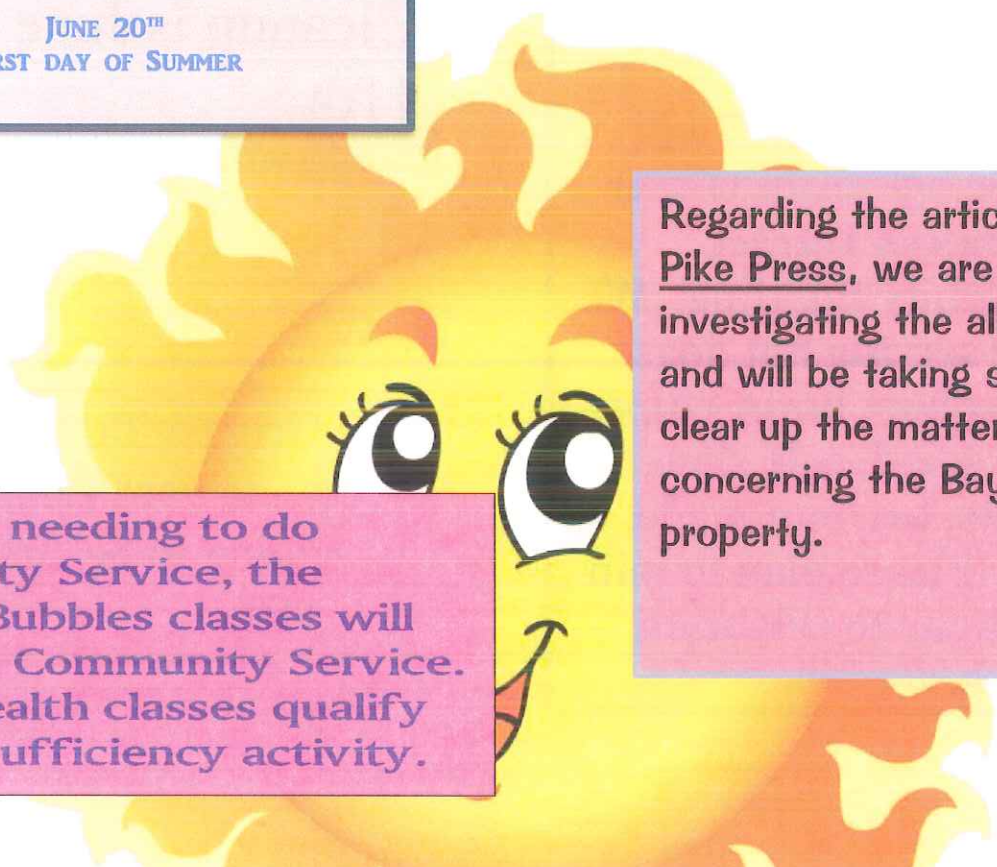

We require a **30 day notice** if you plan to move out of your apartment. If we do not receive this notice you will forfeit any deposit you have paid.

**How late fees work....If your account balance is not paid by the end of the month you will receive a \$25.00 late fee whether you owe .01 or \$100.00. If the balance is not paid in full by the end of the next month you will receive another late fee of \$25.00. You will keep receiving \$25.00 late fees until the balance is paid in full. For example, if the actual last day of the month is a Saturday or Sunday, your payment must be here on Friday before 5:00 pm.**

**CHANGES TO YOUR ACCOUNT WILL STILL GO INTO EFFECT WHETHER YOU RETURN YOUR SIGNED PAPERWORK OR NOT. YOUR RENT WILL STILL GO UP OR DROP EVEN IF YOU DECIDE NOT TO RETURN YOUR PAPERWORK. IT IS HOWEVER REQUIRED THAT YOU RETURN YOUR PAPERWORK, IF YOU DO NOT IT IS A VIOLATION OF YOUR LEASE AND GROUNDS FOR TERMINATION.**
