You are allowed to have a small PLASTIC pool but it must be dumped out after each use. We require this due to insurance and safety issues.

Final electric bills are due by May 31st, if you haven't already paid them. If you find that you will not be able to pay your electric bill in full by the due date you are able to enter into a formal repayment agreement.




