Recertification for **Griggsville-Perry** sites will be **August 27-31**. Please make sure that your paperwork is filled out. If you are not home please leave the paperwork on the counter.

Should something happen to you, we need to know if you have a power of attorney or who you want to take possession of your items. Your family members or friends cannot call here and ask us for a key to your apartment or for us to let them into your apartment without your permission. Please make sure you get this updated information to our office so we can add it to your file. We need either written or verbal permission.

Work orders are done on Mondays. Unless there is an emergency, which is determined by our standards. If you need something fixed make sure you are calling the office so we can put the work order in the computer. Non-emergency work orders are to be completed within 30 days.

We have had few calls from tenants about either electricity problems or water problems. If you have not received a 48 hour written notice from the office about work on electric or water then you will need to call Ameren or your city or town water department to report any problems.

You must clean up any items you leave in the yard otherwise when maintenance comes to mow and they have to pick it up you will receive a \$15.00 charge each time. Also, clean up after your pets, this is a \$10.00 charge each time the maintenance must do it.



Sausage-Tater Crescent Pizza







Ingredients

- package (12 oz) bulk pork sausage
- 1 can (8 oz) Pillsbury™ refrigerated crescent dinner rolls or 1 can (8 oz) Pillsbury™ refrigerated Crescent Dough Sheet
- cup frozen shredded hash brown potatoes
- 1/2 cup shredded Cheddar cheese (2 oz)
 - 3 eggs
- 1/2 teaspoon salt
- 1/8 teaspoon pepper
 - 3 tablespoons milk

Steps

- Heat oven to 375°F. Into 8-inch skillet, crumble sausage. Cook over medium-high heat, stirring frequently, until no longer pink; drain.
- 2 If using crescent rolls: Unroll dough; separate into 4 rectangles. Place in ungreased 13x9-inch pan. Press over bottom and 1/2 inch up sides to form crust; firmly press perforations and edges to seal. If using dough sheet: Unroll dough, Place in ungreased 13x9-inch pan. Press over bottom and 1/2 inch up sides to form crust.
- 3 Spoon sausage evenly over crust. Sprinkle with potatoes and cheese. Beat eggs in medium bowl. Add remaining ingredients; mix well. Pour over cheese in crust.
- 4 Bake 18 to 23 minutes or until center is set and edges are deep golden brown. If desired, serve with salsa. Cover and refrigerate any remaining pizza.

Peanut Butter Cup Cookie Dough Brownies

Ingredients

- roll (16.5 oz) Pillsbury™ refrigerated chocolate chip cookies
- 24 large chocolate-covered peanut butter cup candies, unwrapped
 - box (1 lb 2.4 oz) original supreme brownie mix

 Water, oil and eggs called for
 - Water, oil and eggs called for on brownie mix box

Steps

- 1 Heat oven to 350°F. Line 13x9-inch pan with foil, allowing foil to hang over sides of pan for easy removal after baking. Spray with cooking spray.
- 2 Press cookie dough evenly in bottom of pan. Top with single layer of peanut butter cups. Make brownie batter as directed on box. Spread batter on top of peanut butter cups.
- 3 Bake 30 to 40 minutes or until brownies are set around sides and toothpick inserted in center of brownies (not candies) comes out clean. Cool in pan 20 minutes. Remove brownies from pan by foil edges. Cool completely on cooling rack, about 1 hour. Cut into 6 rows by 4 rows.
