
## Pineapple Upside-Down Dump Cake

#### **Ingredients**

- ¾ cup butter, divided
- 2/3 cup packed brown sugar
- 1 jar (16 oz) maraschino cherries, drained
- 1 can (20 Oz) Pineapple tidbits or crushed Pineapple(in juice), undrained
  - ½ cup chopped pecans, toasted
    - 1 package yellow cake mix

#### **Directions**

- 1. In a microwave, melt ½ C butter; stir in brown sugar. Spread evenly onto bottom of quart slow cooker. Sprinkle with cherries and pecans; top with pineapple. Sprinkle cake mix evenly. Melt remaining butter; drizzle on top.
- 2. Cook, covered, on high until fruit mixture is bubble, about 2 hours.
- 3. Turn off slow cooker; let stand, uncovered 30 minutes before serving



#### The History of Flag Day

When the American Revolution broke out in 1775, the colonists weren't fighting united under a single flag. Instead, most regiments participating in the war for Independence against the British fought under their own flags. In June 1775, the Second Continental Congress met in Philadelphia to create the Continental Army-a unified colonial fighting force- with the hopes of more organized battle against its colonial oppressors. This led to the creation of what was, essentially, the first "American" flag, the Continental Colors. For some, this flag was composed of 13 red and white alternating stripes and a Union Jack in the corner, was too similar to that of the British. George Washington soon realized that flying a flat even remotely close to the British flag was not a great confidence-builder for the revolutionary effort, he turned his efforts towards creating a new symbol of freedom for the soon to be fledgling nation. On June 14, 1777, the Second Continental Congress took a break from writing the Articles of Confederation and passed a resolution stating that "the flag of the United States be 13 stripes, alternate red and white", "and union be 13 stars, white in a blue field, representing a new constellation."




With warmer weather on the way....Please do not leave your dog tied outside without water or food.

Pike County Animal Control has asked us to send out Pet Permits to be filled out and returned to our office.

**License**: pet(s) are to be licensed according to local and/or State of Illinois Code requirements.

**Inoculations:** Resident(s) agree to keep the pet(s) properly inoculated according to local and/or State of Illinois Code requirements.

**Damages:** Resident assume all personal financial responsibility for damages to any personal property caused by the pet(s) and assumes all personal financial responsibility for personal injury to any party caused by the pet(s).

Please read and fill out the Pet Permit enclosed and return to our office. You need to make sure all information is correct and updated.

Two pet(s) allowed. Each must be 35 pounds and under.

**FAILURE TO COMPLY WITH LEASE ATTACHMENT A-Pet Policy**: will result in the removal of the pet(s). If this is not filled out and returned to our office, this will be considered non-compliance. This could result in a 30 day eviction.
