### **ONGOING ISSUES AT PCHA**

#### SMOKING IN OR AROUND UNIT

This problem is discussed on a daily basis. It is in every issue of the newsletter, gone over at lease signings, the No Smoking lease addendum is signed by every member of the household over 18, yet this problem continues.

#### **WE ARE SMOKE FREE**

This means NO SMOKING in unit or within 25 feet of the PCHA buildings. It is very easy to tell if you are smoking in the unit. If we know you are smoking in the unit, we will issue a smoking infraction. If you get 3 smoking infractions, you will receive a termination for non-compliance.

PCHA is a FEDERAL property. Marijuana is a substance the State says is legal, it is not legal ON FEDERAL PROPERTY. No exceptions. If you have the substance in your vehicle on the property this is not allowed. If you are caught with marijuana on the PCHA property, it is a 3 day eviction. NO exceptions.

#### ONGOING ISSUES AT PCHA

#### Tenants abandoning units...

There has been an up-rise in the number of tenants that are leaving units with no notification. These units are in horrible condition. Couches, beds, dressers, clothing, toys, food left in pantries and refrigerators, trash and garbage left on floors, waste and dirty diapers, animal waste, all of these items are left for our maintenance crew to pick up and dispose of.

When this happens, we are charging \$50.00 per haul off load. If your left behind items fill an entire dumpster, the dumpster charge will also be added to your account. Any and all damages from abandoned units, including damage from smoking inside the unit will be charged. We will pursue payment on the account. You will be liable for all court costs.

We do require a 30 day notice for move outs. If a 30 day notice is not given, the \$300.00 deposit is forfeited. If you are not in the unit for 1 year, the deposit is forfeited.

There is no reason for the units that are cleaned and repaired before you move in to be completely destroyed. Our lease clearly states that the units and yards need to be kept in an orderly state. Every adult (18 and over) has signed the lease.

In home inspections will be starting in May, if we see units in bad condition, we will be taking action. While PCHA does not expect the units to be spotless, it does expect them to be free of noxious odors, debris, garbage, clutters, mounds of dirty dishes, dirty stove, dirty refrigerators, etc. If you have pets, we do not expect to find urine and feces in the interior of the unit or significant damages caused by the animals. We also do not expect to find pet waste NOT being picked up in the yard.

#### **New Policies Acceptance Form**

This form is in regards to the policy revisions recently passed by the Pike County Housing Authority (PCHA). All of the policy revisions were done in order to be consistent with HUD updates and/or to improve the operations of PCHA.

The policy revisions were approved as drafts at PCHA's 12/21/2021 Board meeting. The policy revisions were then available for review by requesting copies, online at <a href="https://www.pikehousing.com">www.pikehousing.com</a>, and at PCHA's Community Building located at 842 Mason Street, Barry, Illinois. After a 30+ day comment period, a public meeting was held on 2/11/2022 at the PCHA Community Building on the policy revisions. There was no attendance at the public meeting for the policy revisions and no comments were received prior to the public meeting. As a result, the policy revisions were ratified as final at PCHA's 2/23/2022 Board meeting.

The policy revisions went into effect immediately for each household after the final approval.

#### No tenant is grandfathered in to the old policies.

Policy Revisions affected were:

Repayment Agreement Policy & Repayment Agreement Violence Against Women Act (VAWA) Policy Tenant Charge List Admissions & Continued Occupancy Policy (ACOP) Dwelling Lease

Per PCHA's policies, each tenant household must indicate acceptance of the policy revisions.

Each tenant household has 30 days to return this document accepting the above policy revisions and the incorporation of the policy revisions into each tenant household.

Failure to accept the policy revisions will leave the tenant household subject to termination for good cause in accordance with the policies in Chapter 13 of PCHA's ACOP.
