
Be alert and aware for severe weather. Know the best place to go in your home to be the safest. Keep weather information tuned in or turned on.



BLACK BEAN & CORN GUACAMOLE

- 3 MEDIUM RIPE AVOCADOS, PEELED AND CUBED
- 2 TO 3 TBS FRESH LIME JUICE
- 1/2 TO 1 TSP KOSHER SALT
- 1/2 C. BLACK BEANS, RINSED AND DRAINED
- 1/2 C. UNCOOKED FRESH WHOLE KERNEL CORN
- 1/4 TSP COARSELY GROUND PEPPER

IN A BOWL, MASH AVOCADOS UNTIL ALMOST SMOOTH. STIR IN LIME JUICE AND SALT. LET STAND 10 MINUTES TO ALLOW FLAVORS TO BLEND. TOP WITH BLACK BEANS, CORN AND PEPPER.

PICK UP AFTER YOUR PETS!

We have been receiving a lot of calls concerning pets on PCHA properties. All animals need to have a pet permit filled out on them and returned to the office, you will then receive a pet sticker to be placed on the front door. If you have a pet or pets and do not have a pet sticker, please call the office.


Pets are allowed on PCHA properties, but they must be taken care of! If you have a pet, you must follow the rules set forth in the **Pet Policy**. You must follow certain rules for emotional support or service animals as well. You were given a copy of the Pet Policy when you signed your lease, if you need a copy, please call the office.

No aggressive behavior will be tolerated for the safety of our tenants, tenant's guest, PCHA employees and third party contractors.

You need to be aware of your properties pest control day and secure your animals' appropriately. Pest control calendars are mailed out at the first of the year, are in the Newsletter, and on our website. If you need a new copy of the pest control schedule, please call the office.

Your pets are not allowed to run freely on the properties. You must have them tied securely in the yard or on a leash. This prevents the animals from going onto other tenant's yards and making a mess.

If you have a pet that is not registered with this office, you must contact the office and ask for a Pet Permit.



YOUR CHECKLIST FOR BETTER HEALTH

- Jump start your day with breakfast. Try a high-fiber cereal topped with berries.
- Split bulk items or fresh produce with friends.
- Drink fluids throughout the day even though you may feel less thirsty as you age.
- Avoid sitting for long periods of time in front of a TV or computer.
- Limit drinks and foods with fats and added sugars. Drink fat-free milk instead of sodas. Avoid foods with butter, shortening, and other solid fats.
- Put down the salt shaker. Cut slat to 2/3 teaspoon a day.
- Get enough sleep.
- Strengthen your muscles twice a week to ward off frailty and muscle loss. Climb stairs, lift weights or use an exercise band.

Some exterior surfaces on these properties are in need of repair. We expect the repairs to be done in the next 60 days.




Board Member needed...


You must pay your Ameren bill

Pike County Housing Authority would like to remind our tenants that PCHA will cover the cost of West Central Mass Transits rides for medical, education, employment, shopping (local food & beverage, dry goods and pharmaceuticals), congregate meals, professional services (not including barber/beauty shops, nail salons, etc.), legal, court ordered, financial, and social service appointments.

Not covered by PCHA are shopping trips to Jacksonville/Quincy etc. for "recreational shopping", recreational activities such as restaurants, movie theaters, events, or other personal trips. You can still use the service for your personal recreational activities but tenants would pay their own fares.
