

Pike County Housing Authority would like to remind our tenants that PCHA will cover the cost of West Central Mass Transits rides for medical, education, employment, shopping (local food & beverage, dry goods and pharmaceuticals), congregate meals, professional services (not including barber/beauty shops, nail salons, etc.), legal, court ordered, financial, and social service appointments.

Not covered by PCHA are shopping trips to Jacksonville/Quincy etc. for "recreational shopping", recreational activities such as restaurants, movie theaters, events, or other personal trips.

You can still use the service for your personal recreational activities but tenants would pay their own fares. Same day trips maybe accepted, upcharge fee will be tenant's responsibility.



# Rent must be paid every month!

If your account is 60 past due, an eviction for non-payment will be issued.

Rent is charged the first of each month, but is not due until the 25<sup>th</sup> of each month.

Assistant animals are a means to provide a reasonable accommodation for an individual with a disability, but a person with a disability is not automatically entitled to have an assistance animal.

PCHA is permitted to request verification the assistance animal is needed to assist with a disability.

# **CHANGES IN HOUSEHOLD**

If your household changes, meaning individuals who are listed on the lease, including minors, are no longer living at the apartment, you need to contact PCHA as soon as possible. We will require documents proving the individual(s) are living elsewhere. Once that is received you will need to schedule an appointment to come in and sign a new paperwork packet, including a new lease. If you have a child who is turning or has turned 18, you need to contact PCHA to sign a new paperwork packet, including a new lease. If a new paperwork packet is needed, all members of the household who are 18 and over, will need to be present to sign the documents. These signings will be by appointment only.



In the event that maintenance or pest control report to our office that you are smoking in your unit, we will schedule an inspection. If it is proven you have been smoking in the unit, you will receive an infraction against your lease. If you get 3 smoking infractions you will be eligible for eviction, and you will be charged for damage caused by smoking in the unit.

This is non-negotiable.

Every tenant (over 18) has signed the No Smoking lease addendum.

Sale of Baylis & Perry Properties

Demolition of up to 32 units in Pittsfield





The Pike County Housing Authority board approved the formal resolution approving the future sale of the PCHA's Baylis & Perry properties. PCHA has approved an Interagency Agreement with Menard County HA for HCV TPV administration. This will allow Menard County HA to operate in Pike County for the purpose of administering the Tenant Protection Vouchers. PCHA has received a letter of support from the City of Pittsfield for PCHA's efforts for demolition of up to 32 units in Pittsfield.

#### PCHA'S ANNUAL AUDIT

Pam Simpson Audit FY 2022

#### PUBLIC NOTICE

The PCHA has available for public review and comment its updated Federal Fiscal Year (FFY) 2024 Flat Rent Policy. This policy has been updated to incorporate HUD supplied data for FFY 2024 Fair Market Rents and FFY 2024 Unadjusted Rents. HUD requires the updated FFY 2024 Fair Market Rents and FFY 2024 Unadjusted Rents to be in effect as of 10/1/2023 and to be incorporate into the housing authority's payment standards upon final PCHA policy ratification.
